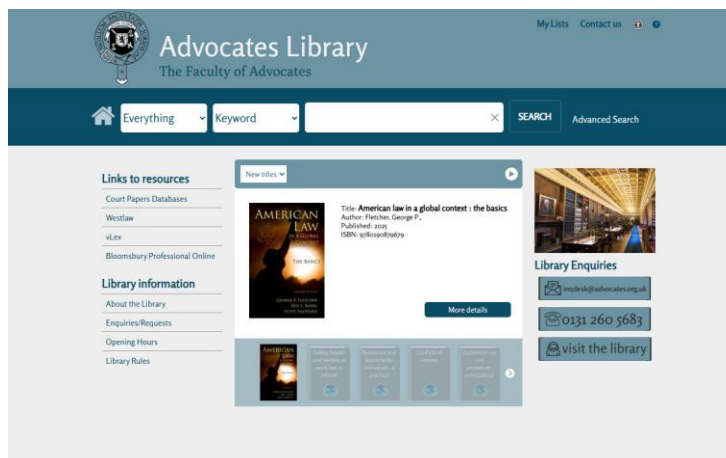
Enterprise User Profiles

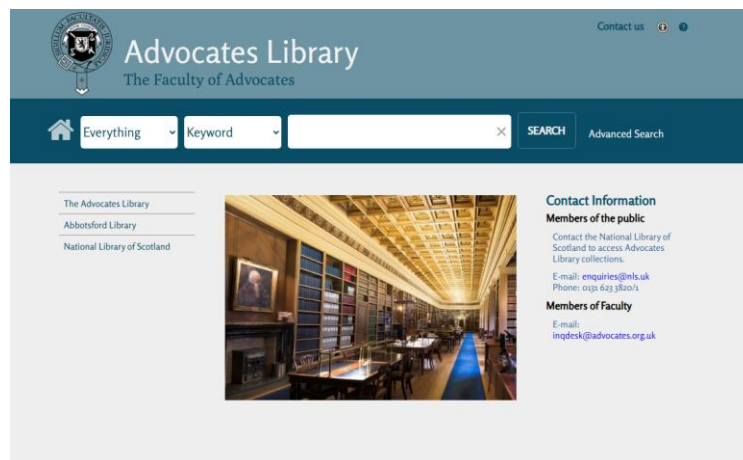

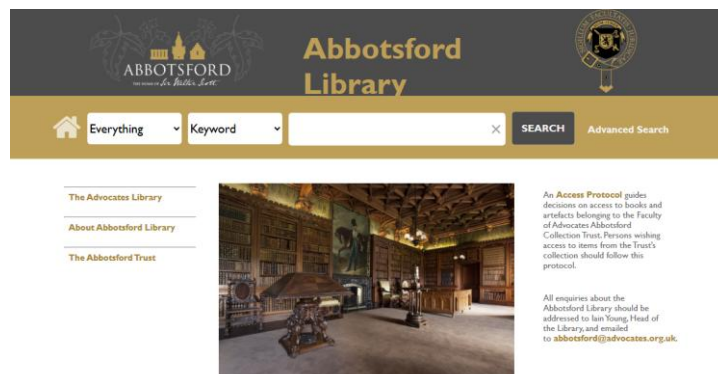

Why tabbed search results?

- To allow members to decide whether or not they need to come into the Library to read their item
- To indicate if an item is in print or electronic formats
- To show that we might have a mix of formats for a title
- To highlight the different formats available
- To show the value of our legal deposit remit, the NPLD (Non-Print Legal Deposit) in particular

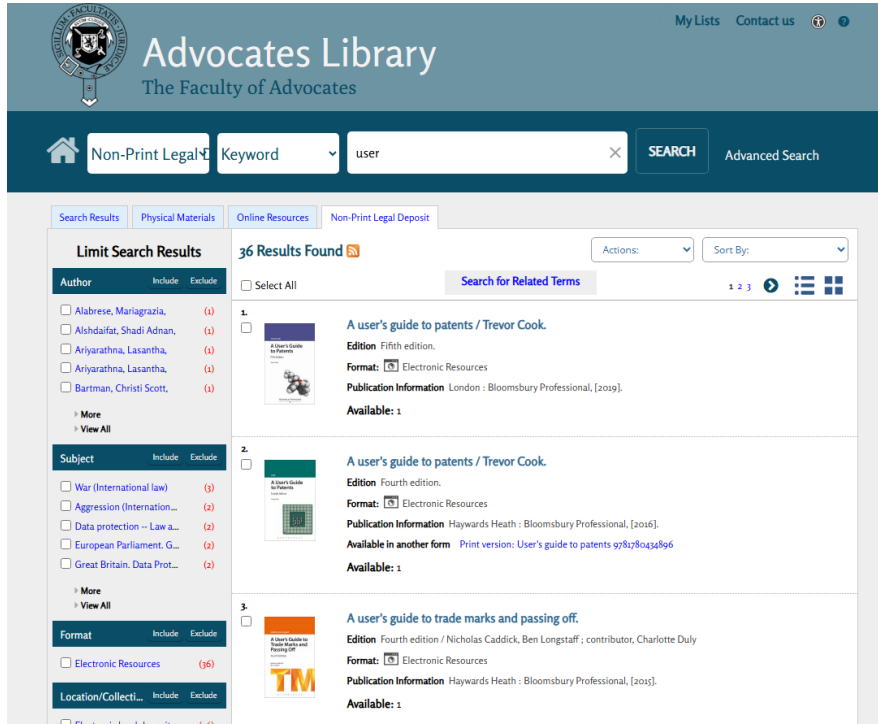

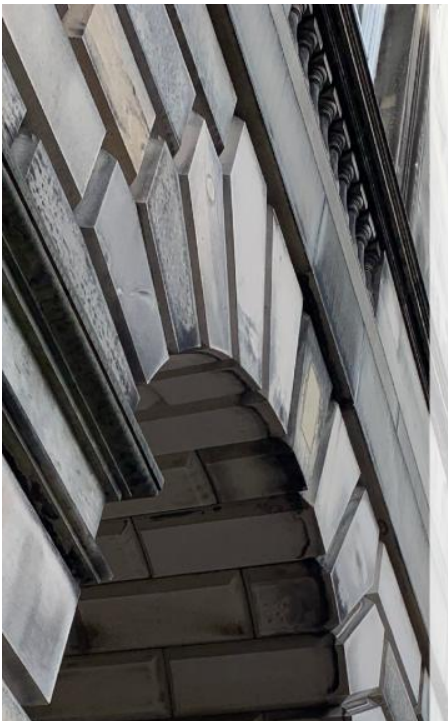


How tabbed search works

- Each search tab is defined to use a pre-defined search target and / or limit (e.g., limit by electronic items). Clicking in a tab re-performs the same search, but removes any search target and limit, replacing them with the new tab's target and limit.
